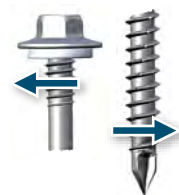

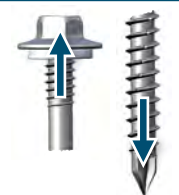

ULTIMATE TENSILE STRENGTH



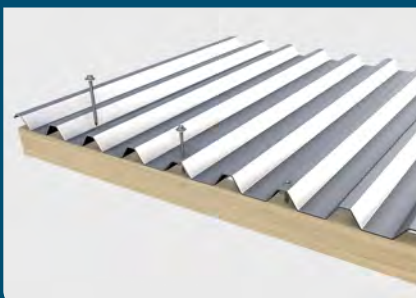
